? Quality enhancement is taken care of by various methods such as regular class tests, internal tests, model exams, paper presentation, industrial visits, seminars and workshops. ? Three internal tests are conducted in a centralized manner. Question papers are set and given to the faculty in charge of internal tests to be printed. The average of the best two internal test marks (20) plus assignment marks (5) are calculated for internal marks. For PG students, the

average of the best two internal marks (15) and seminar marks (6) and assignment (4) marks are calculated for internals. ? Portion for internal tests are informed in the beginning of each academic year. Faculty members are sure of what to teach during each month and students are well aware of the portions to be learnt for internal tests. ? Key answers for valuation of internal test are given to the faculty by the staff in charge and internal test notebooks are valued and handed over to the students before the beginning of the next internal tests. Students are allowed to clarify their doubts in evaluation and the staff member in charge immediately rectifies the mistakes in valuation or in calculation.

? The institution prepares the Handbook and Calendar well in advance. The students and the faculty know the papers prescribed for each semester with subject code. The institution has a built-in mechanism to ensure curriculum completion within the planned time frame. A well planned calendar is published for the entire year and individualized comprehensive work plans are prepared at the beginning of each semester. There is a constant monitoring by the Heads of the Departments in the implementation of the work plan. Working days lost due to rain holidays and local holidays are compensated by conducting special classes during zero hours.
